About the ESG Exclusion Checklist for Business Activities:

The ELFA ESG Exclusion List for Business Activities is aimed at allowing CLO managers to easily screen out loan investments based on ESG criteria.

The checklist is designed to be completed by arranging banks at the time of a new corporate loan or bond syndication. This ensures that investors can quickly determine if a corporate borrower's business activities would breach one of their internal guidelines, and makes it easier for the company to publish this data to its entire syndicate.

Our aim is for the tool to increase efficiency in the market and to be useful for a range of market participants.

To gather input from market participants, we are launching the ELFA ESG Exclusion List for Business Activities to general consultation from now until 15 December with an aim to release the final version in January 2022.
